**IV. Permit Conditions**

Upon issuance of the permit, permittee accepts the following permit conditions:

1. Adequate precautions shall be taken at all times to ensure safe and lawful storage, transport, construction, and display ignition of any and all fireworks authorized under Chapter 8.35 of the Borough Code. No fireworks in violation of any limitation established by the State of Alaska will be used in this display.
2. Incidents resulting in the injury of property and persons as a result of this permit shall be prima facie evidence of negligence on the part of the permittee and penalties provided under MSB 8.35.080 shall be sought by the Matanuska-Susitna Borough. Permittee shall hold harmless, defend and indemnify the Matanuska-Susitna Borough from any or all legal actions or claims of any character whatsoever resulting in economic loss, property damage or destruction, personal injury or death which may arise from any incident pursuant to the exercise or failure to properly exercise this permit.
3. Applicant shall notify the Emergency Services Department (373-8800) 24 hours prior to the permitted activity.
