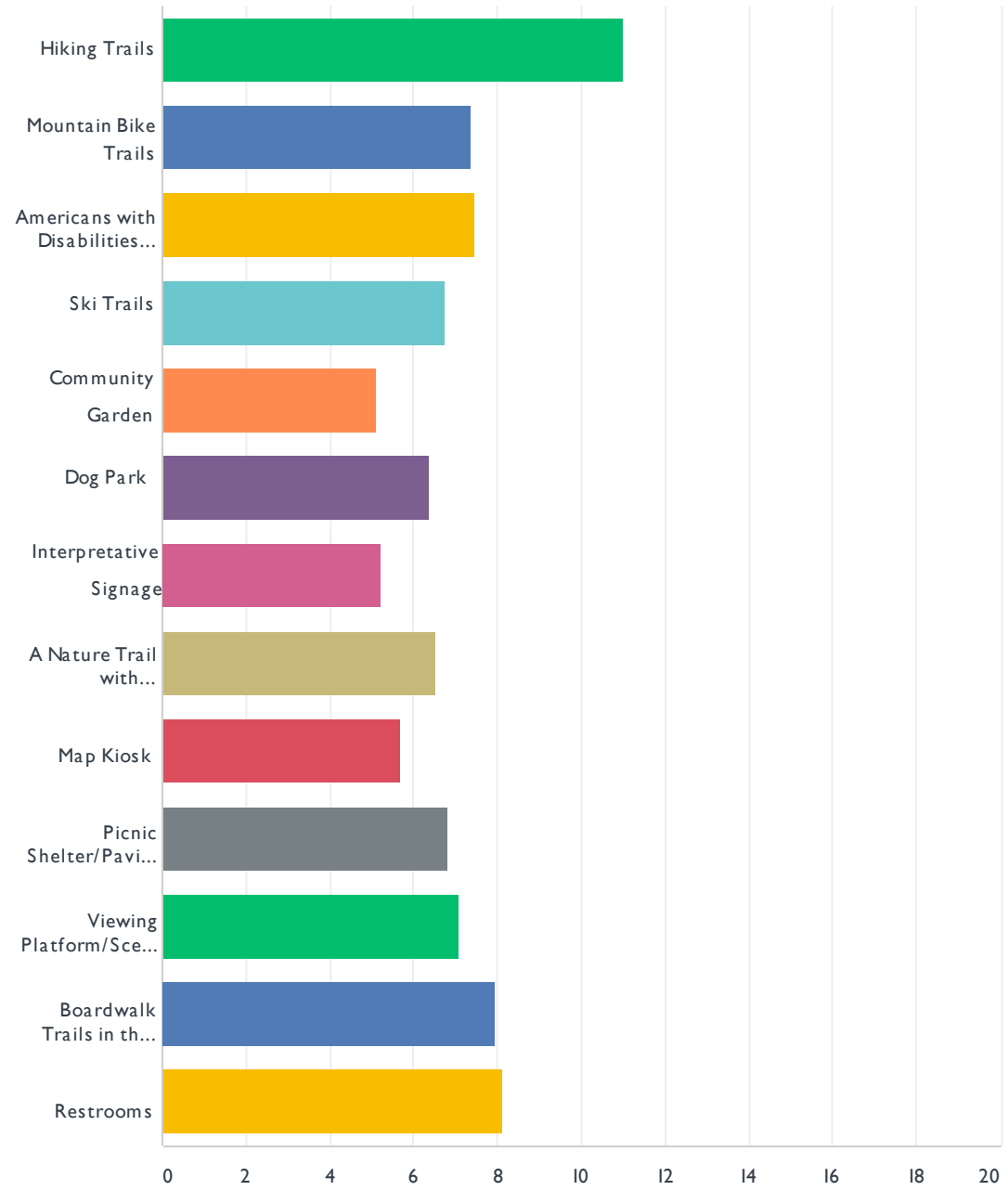


Q1 Please rate the level of priority your local community should place on investing in each of the following facilities at the Settlers Bay Coastal Park over the next five years:

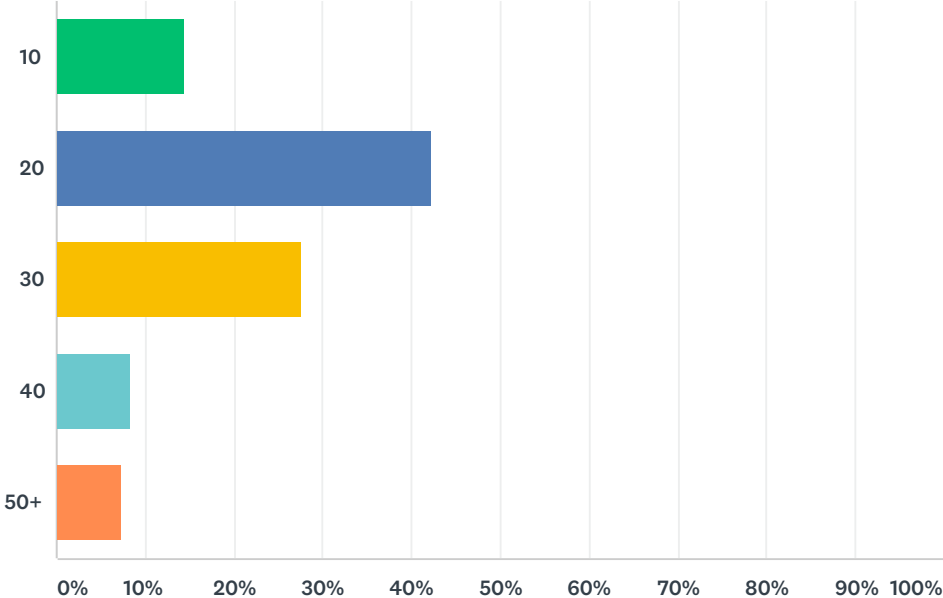

Q2 How many cars should be able to park at the west entrance?

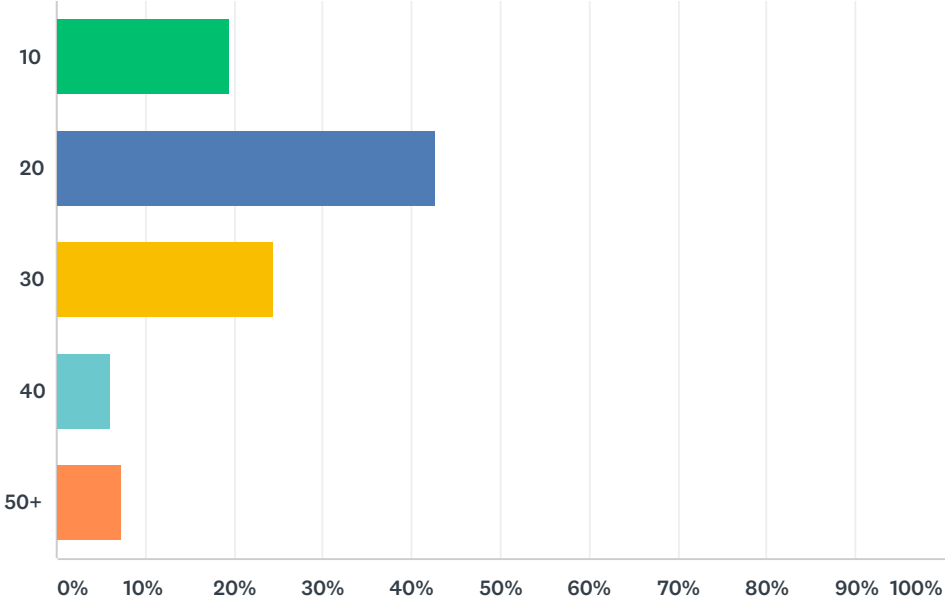

I would like to suggest that additional speed bumps are added to Settlers Bay access points and signs placed at the beginning of each trailhead that inform the parties, wildlife may be present. AND ALTHOUGH I RANKED EACH ITEM, HAD I NOT BEEN FORCED TO DO SO, I WOULD HAVE PUT A 1 FOR ESSENTIAL ITEMS, SUCH AS hiking trails, restrooms, map kiosk, interpretive and wayfinding signage, viewing platform ski trails, are all necessary priorities. NOTE, I PUT A 2 ON INTERPRETIVE SIGNAGE HOPOING IT WOULD INCLUDE WAYFINDING SIGNAGE... I DID NOT SEE A LINE ITEM FOR SIGNAGE TO KEEP FOLKS FROM GETTING LOST. THAT IS AN ESSENTIAL PART OF TRAIL DEVELOPMENT.....I PUT SKI TRAILS DOWN ON THE LIST BECAUSE I THINK THE HIKING TRAILS CAN BE USED FOR SKIING IN THE WINTER, AND THERE IS NO NEED TO MAKE THE WHOLE AREA A CAN OF WORKS NETWORK OF TRAILS.
