<u>Central Landfill Gravel</u>: Borough staff had been preparing to issue a request for proposals (RFP) to lease a portion of the Central Landfill to set up a mining and process area to remove soil/gravel materials for future cells. The intent is to reduce the cost of development for future cells. At the December 7 Assembly meeting, the Assembly will be considering a referral to the Planning Commission of an ordinance to exclude the Central Landfill from the Conditional Use Permit requirement. Therefore, staff will delay issuing this RFP until this ordinance is brought forward.

<u>Severance Tax Update</u>: The Assembly is having a special meeting at 4 p.m. December 7 to discuss the merits of a potential severance tax. A severance tax, in this instance, might apply to large gravel pit operators in the Borough. A gravel tax may be a potential way to raise revenues to pay for the recently voter-approved transportation package in lieu of taking on additional debt. The special meeting will provide the Assembly the opportunity to hear from the gravel industry and the public. No action will be taken on this item; the special meeting is purely informational.


