<u>Build Back Better Regional Challenge</u> – The U.S. Economic Development Administration (EDA) notified the Borough that our proposal for a grant through the Build Back Better Challenge did not advance to Phase 2. This project was the Alaska Railbelt Clean Energy Transportation Infrastructure project created in partnership with the Fairbanks North Star Borough, Interior Gas Utility, and Alaska Railroad Corporation for:

- 1) Expanding LNG capacity at the publicly owned IGU Titan plant in Point MacKenzie
- 2) Completing 18 miles of the Port MacKenzie Rail Extension (PMRE), which will allow LNG to be shipped by rail to Fairbanks and North Pole; and
- 3) Completing rail spur connections to the Titan plant and to IGU storage and vaporization facilities in Fairbanks and North Pole.


The Borough will continue to promote this project at the State and Federal levels.


<u>Schedule of Rates and Fees</u> – An Assembly member requested revenue projections for the Landfill as part of the schedule of rates and fees discussion. Those projections are below and are being shared with the entire Assembly prior to next week's meeting. The overall projected increase is 1.93% from the current fiscal year.

The three following charts describe the projected revenues and expenses over time to show where large capital outlays are required for events such as cell openings and closures. This is intended to illustrate how recurring revenue is needed to prepare for these large projects as opposed to taking on additional loans for these projects.


