<u>Challenged Materials in Borough Libraries</u>: After the most recent challenged materials review committee meeting on January 18, I am suspending our challenged review materials policy. The meetings have devolved into a shouting match and name-calling that is not producing a positive outcome for our community. I acknowledge the value of having a process for patrons to challenge material, but until such time as we can come up with a different approach, there is no value in continuing to put materials through the current process.

Since this process began, the status of four books has changed because of the challenges. Three books were moved from the young adult section to the adult section, and one was removed from the shelf altogether. Our libraries have not provided materials that violate state or federal laws. If material were identified as violating a law, it would be removed immediately.

Additionally, we are changing the labeling of the young adult section from ages 14-17 to 16-17. This is intended to communicate that there may be materials in the young adult section that some may deem inappropriate for 14- and 15-year-olds, and parents can make those decisions. Borough youth library cards require a parental signature acknowledging that control of what a minor checks out is the responsibility of the parent. The parent of record can log into their children's accounts online to view what has been checked out, and our libraries will provide check-out information to them as well.

Additionally, I have asked staff to cancel the Library Advisory Board meeting that was planned for February 13 for the reasons stated above. I will provide an update at the next Assembly meeting. Please do not hesitate to contact me if you have questions.
