#### **MEMORANDUM**

<u>Alaska State Troopers Staffing</u>: At the Strategic Planning meeting on August 10, the Assembly asked for a summary of the State Trooper manning levels and a crime statistics report. The crime statistics for each year are typically produced in September each year for the previous year. The Trooper Public Affairs Officer, Austin McDaniel, has agreed to brief the Assembly on those statistics in October. For the Trooper manning summary, the Trooper B Detachment Commander provided the following current summary:

1. Statewide, for DPS, there are 411 commissioned positions. 348 commissioned positions are filled, leaving 63 vacant (15% vacancy rate). 23 candidates are currently enrolled in the Academy. This includes commissioned positions within both divisions of the State Troopers and the Wildlife Troopers.

2. DPS within the Mat-Su Borough has 81 total commissioned positions: 63 of those commissioned positions are filled, and 18 commissioned positions are vacant (22% vacancy rate). Specific to Alaska State Troopers B Detachment within the Mat-Su Borough, there are 49 positions, with 13 vacant (27% vacancy rate). B Detachment includes the patrol function and their responsibilities at the Palmer Court. The other 32 positions, from the 81 above, are not assigned to B Detachment. They include Troopers assigned to the Wildlife Troopers, Major Crimes Investigations, Child Crimes Investigations, Special Crimes, and positions assigned to the Statewide Drug Enforcement Unit.

<u>Safe Streets for All (SS4A)</u>: The Bipartisan Infrastructure Law (BIL) established the SS4A discretionary program, which funds grants to prevent roadway deaths and serious injuries. Before proceeding with implementation funding, the program requires completing a Comprehensive Safety Action Plan (CSAP), which includes a community survey. Borough staff and our consultant have created a website describing the effort and provided information via social media and to community councils and various community groups. The Borough website is located at <u>https://ss4a.matsugov.us/</u>. Funding was accepted on October 3, 2023 via OR 23-090 and a contract to develop the CSAP was approved on May 7, 2024 via AM 24-054. **Talkeetna Flooding/Erosion Funding:** At the August 10 Strategic Planning meeting, an Assembly member asked for a summary of our spending on Talkeetna flooding and erosion issues over the last 10 years. Our current system can quickly pull project data back to 2010. There has not been extensive spending in recent years other than events in 2020 and 2023. Spending is as follows.

Fund 290 – Talkeetna Flood Control has a projected fund balance of \$113,296 on June 30, 2025.

## WHY A COMPREHENSIVE SAFETY ACTION PLAN?

From 2013-2022, law enforcement reports show the Mat-Su Borough expanded core area had nearly 10,000 roadway crashes including:

- +100 fatal crashes
- 345 serious injury crashes
- 69 crashes involving bicycles and pedestrians, 93% of which resulted in injury or death

There is more to be done to improve these statistics and reduce the impact these losses cause to the community.

This plan will follow the Safe System Approach, a national roadway safety strategy developed by the U.S. Department of Transportation.

The Safe System Approach recognizes that humans are vulnerable and sometimes make mistakes, which means multiple layers of protection must be in place to help prevent crashes and minimize the severity of injuries when they do happen.

This plan will help the Mat-Su Borough understand what factors contribute to crashes within its expanded core area, and recommend tools and strategies to prevent them. This includes things like changes to roadway design, education and outreach, and review of policies and enforcement actions that support safety.

It is the policy of the Mat-Su Borough that no one shall be subject to discrimination on the basis of race, color, national origin, sex, age, or disability. The Mat-Su Borough complies with Title II of the Americans with Disabilities Act of 1990.
