**MATANUSKA-SUSITNA BOROUGH
ORDINANCE SERIAL NO. 17-019**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY AMENDING MSB 15.24.030(B)(5), UPDATING THE CITY OF HOUSTON COMPREHENSIVE PLAN.

BE IT ENACTED:

Section 1. Classification. This ordinance is of a general and permanent nature and shall become a part of the Borough Code.

Section. 2. Adoption of plan. The Borough Assembly hereby adopts the 2016 City of Houston Comprehensive Plan.

Section 3. Amendment of section. MSB 15.24.030(B)(5) is hereby amended as follows:

Ordinance Serial No. 90-032 dated May 1990, Ordinance Serial No. 99-070, Ordinance Serial No. 03-108 dated July 2003, Ordinance Serial No. 17-019, dated February 2017);

Section 3. Effective date. This ordinance shall take effect upon adoption.


Section 4. City of Houston Community Impact Assessment. The Matanuska-Susitna Borough Assembly recognizes that a preferred route for the Port to Parks road corridor is included in the Comprehensive Plan Update and Community Impact Assessment. However, the Borough Assembly is not endorsing or selecting a route and further declares the Borough staff will not seek to advance any route until the Assembly has selected a route.
